## **AGREEMENT**

#### **1. Preamble**

SSPH+ will showcase Swiss public health sciences related to the 17 Sustainable Development Goals (SDG’s) at the Swiss Pavilion of the Dubai Expo 2020 (postponed to Oct 2021-March 2022). During the Health and Wellness week (27 January-2 February 2022), SSPH+ will showcase an onsite and online digital quiz that features “health in relation to all SDG’s”.

This contract settles the conditions for the partnership with Swiss learning who will be represented within the framework of the SSPH+ quiz.

For this purpose, the Parties agree as follows:

#### **2. Conditions**

- SSPH+ features Swiss Learning in the SSPH+ quiz in association with 2 quiz questions (showcased live at the Expo from 27.01-09.02.22 and online- indefinitely) by 1) name, 2) logo and 3) an image and/or short 20-word statement of choice provided by Swiss Learning. These are reviewed/ approved by Swiss Learning and SSPH+.
- SSPH+ lists Swiss Learning as a supporter of the SSPH+ quiz within the digital extension (online web version) of the quiz.
- SSPH+ lists Swiss Learning on the SSPH+@Expo website as a supporter of the quiz.

### 3. Allocated funds

Swiss Learning allocates the amount of **CHF 5'000.-** towards the SSPH+ quiz.

### 4. Term of the Agreement

This Agreement shall commence on the day of mutual signing and shall expire automatically by 09.02.2022.

### 5. Notices

All notices regarding the Agreement required or permitted hereunder shall be in writing addressed to the respective Parties as set forth herein and shall be delivered and signed electronically, per email.


